**RESERVATION TERMS AND CONDITIONS**  
**ALL-GAY BLACK SEA CRUISE**

**DEPOSIT AND PAYMENTS:** An initial deposit of \$500.00 per person (\$1000 for singles) is required to make a reservation. A second deposit of \$1000 per person (\$2000 for singles) is due August 11, 2009. Full and final payment is February 10, 2010. If reservation is made after February 11, 2010 full payment is due at that time. TRAVELPRIDE accepts Visa, MasterCard, American Express and Discover cards. The credit card used must be in the name of the traveler or the traveler's cabin mate.

**CANCELLATION POLICY:** Should you need to cancel or change your reservation to another TRAVELPRIDE CRUISE, your refund will be subject to a cancellation charge based upon the following schedule:

**TRIP CANCELLATION INSURANCE INFORMATION:** Trip Cancellation Insurance is available and is highly recommended. You will receive information upon confirmation of your tour program. Should you have questions, please consult your travel professional or TRAVELPRIDE.

**PASSPORTS AND VISAS:** A valid Passport is required for travel and through the entirety of your vacation. **US CITIZENS require a visa for travel to Turkey. It is the responsibility of each traveler to insure they have a valid passport and visa and for non-US citizens to insure they have proper visas and meet all international travel requirements.**

**DOCUMENTS:** Final documents will not be released unless a copy of the signed Reservation Form is on file in our office. All pertinent documents will be sent to the address on file and approximately two weeks prior to your cruise.

**PARTICIPATION:** This is a full-ship private charter for gay men and women and is marketed to the GLBT community. TRAVELPRIDE requires that all participants be at least 21 years of age on the first day of sailing. TRAVELPRIDE reserves the right, at any time, to refuse participation to any passenger(s) who we deem may be a danger to any and all passengers, and/or disruptive to the vacation. We reserve the right to terminate participation of any passenger(s) should their conduct so warrant. TRAVELPRIDE will not be accountable nor will incur or pay any costs, travel or otherwise, associated with the termination of any disruptive passenger(s). **We require that if you have any special medical, physical or other requirements be brought to our attention immediately upon receipt of this document.**

**WHAT IS INCLUDED:** Your TRAVELPRIDE VACATION includes all items as noted in the electronic brochure, our website and printed materials. This includes accommodations in the category selected based upon double occupancy (two in a cabin). Single cabins are available at the supplement noted. **All ship board meals and snacks, select wines, spirits, non-alcoholic beverages, and entertainment are included.** Optional tours may be offered at a supplemental charge. **Items of a personal nature such as premium or ultra-premium wine or spirits, laundry, and telephone calls are not included.** Ship board gratuities on the rate schedule are prepaid. Gratuities ashore to tour guides and drivers are at your discretion.

Furthermore, you agree and release TRAVELPRIDE, its employees, principals, representatives, agents and parent company from any liability, loss, expense, damages, or claims arising from the distribution, broadcast, sale or use of your likeness, or voice. If you do not wish to be part of future media advertisements or marketing materials, **you may rescind this release in writing at any time prior to your return from the cruise. Your right to rescind shall be forever waived after you depart the cruise vessel and tour.**

**LIABILITY AND RESPONSIBILITY:** When you make a reservation or accept tickets in connection with a TRAVELPRIDE vacation it shall be deemed your acceptance of these terms and conditions. TRAVELPRIDE, the tour operator, acts solely as an agent for the guest and TRAVELPRIDE, its owners, staff, and employees shall have no responsibility for the acts, errors and omissions of the airlines, cruise lines, transportation companies, hotels, tour operators and any other suppliers providing services (These are collectively the "Suppliers"). You agree to hold TRAVELPRIDE free of responsibility for, and bear any risk of, delays, loss or accidents, claims, liability for the fault or negligence of any company or individual providing such service. You agree to abide by the customs regulations and all laws, local and national, of the locations visited on this tour. All tickets, vouchers, receipts, coupons are issued subject to the terms, limitations and agreements set for by the Suppliers. The liability of TRAVELPRIDE and the Suppliers is limited and governed in strict accordance with the terms and conditions contained in any passage ticket contract in effect at the time of the cruise, tour or event and these terms and conditions are binding upon you. By accepting tickets, coupons, vouchers or receipts and/or using the services, you accept and agree that neither TRAVELPRIDE, the Suppliers, nor their owners, principals, affiliates, agents, employees, or other representatives shall be liable for any loss, injury, damage to you or your belongings, or in any way connected with any occurrence beyond their control, including Acts of God, hostilities, labor conflicts, strikes, war, fire, mechanical breakdown, arrest, orders or restraints by governmental bodies, acts of terror, civil unrest, weather and safety considerations or any other circumstance beyond the control of TRAVELPRIDE. You agree to abide by the rules of Suppliers and agree to participate in activities and/or use facilities of the Suppliers or TRAVELPRIDE at your own risk. You also agree to the general terms and conditions of each Supplier's program, including advertised cruise lines, as detailed in their current brochure and/or Passenger Ticket or Contract then in effect. A copy of these terms and conditions is available upon request. In the event of a major change in a program, including ship, hotel, dates, departure or destination city becomes necessary, TRAVELPRIDE will notify you as soon as possible. If you find the revised arrangements unacceptable, you will have the option of canceling without penalty, provided you do so within seven days of such notification. In the event of a change, we will try to substitute comparable services. Cruise ship itineraries are always subject to change without notice and any alterations except embarkation and disembarkation point is not considered a major change. Neither TRAVELPRIDE, the cruise lines nor other Suppliers shall be responsible, financial or otherwise, for any ship's failure to adhere to a published arrival and departure time in any port.

In the event of cancellation of your cruise by TRAVELPRIDE or our Supplier(s), you agree that TRAVELPRIDE shall only be liable to you for any deposits or payments made on your cruise and shall not be responsible for any other costs incurred by you in preparation for your trip or for any other consequential damages arising from such cancellation. TRAVELPRIDE reserves the right to cancel the cruise or tour at any time and full refund of all monies constitutes full settlement of its obligations. TRAVELPRIDE reserves the right to decline to accept or retain any person as a member of this cruise or tour.

Once we have received your deposit or full payment, your rate is guaranteed except in the event of a substantial increase in operating costs, fuel costs, insurances, tariffs, taxes or port charges prior to the sailing date. If we must ever add a surcharge, it will not exceed \$300.00 per person. All governmental fees and taxes are subject to change without notice at any time and we reserve the right to add a surcharge for these fees and taxes at any time regardless of deposit or payment status you have with TRAVELPRIDE.
